Activity

During the 3rd quarter of 2016 the Precia Molen Group achieved a turnover of 27.5 M€.

For the first nine months of the year 2016, the turnover is 80.5 M€, increasing by 3.6% compared to the same period in 2015. At constant perimeter and currencies rates, organic growth amounted to 2.7%. The impact of acquisitions amounts to 2.0% while currencies effects amount to -1.1%.

Activity for the third quarter improves compared to the first half with the increased contribution of several acquisitions made on the first part of the year and a steady increase of our export markets. The Asia-Pacific region sees its sales improved by 41.2% (external growth excluded), Brazil and Scandinavia are also very dynamic (+ 31.9% and 39.5% respectively). In Europe, sales remained well oriented (+ 4.7% organic growth), despite a poor performance in the United Kingdom (lower sales and strong impact of currency). In France, our turnover is stable for 9 months.

Forecasts and outlook

The backlog of the company remains well oriented on the year end although in slight decrease compared to the first half.

The Group turnover for the year 2016 should therefore reach the target set at 110 M€.
